THE CREDIBILITY OF HAVING WALKED IN THEIR SHOES HELPS THE CHILDREN TO TRUST AND FEEL COMFORTABLE ASKING QUESTIONS AND SEEK SUPPORT AND UNDERSTANDING IN DEALING WITH PERSONAL DIFFICULTIES. THIS SUPPORT HELPS SOCIAL RE-ENTRY, RE-ENTRY BACK INTO SOCIETY IS WHERE THE HEALING BEGINS, OUR AIM IS TO HELP PARENTS AVOID MAJOR MISTAKES THAT WILL SLOW DOWN THEIR CHILDREN'S RE-ENTRY BACK INTO SOCIETY. FOR EXAMPLE, MANY PARENTS WILL HIDE THEIR CHILDREN BEHIND DOORS, BECAUSE THE PARENTS CANNOT DEAL WITH THE PUBLIC'S REACTION TO THEIR CHILD'S APPEARANCE.
